# Terms and Conditions



## The reservation

- Reservations can be made by mail, telephone, or e-mail. Before sending any reservation, call for availability.
- Booking a location or a rental involves signing a reservation contract. The payment of a deposit corresponding to **25% of the total amount of the stay** plus the booking fee of **20 € for a rental**. The payment of **a deposit of 75 €** plus the booking fee of **20 € for a location**.
- The reservation is final once it has received **written confirmation** from us.
- The balance of the stay must be paid at the latest **one month before** the day of your arrival. In the event that the balance is not paid within the time limits indicated, it is considered canceled.
- No news from you 24 hours after the scheduled date, the reservation will be canceled without you being entitled to any compensation. You can take out cancellation insurance with our partners.
- **In case of cancellation** or early departure without insurance: **all amounts paid remain at the campsite**.
- In case of cancellation or early departure confidently your stay will be refunded under the conditions mentioned in the insurance contract.

## The location

- **The pitch** reserved is available **from 15 p.m. to 18:30 p.m. on day of arrival** and must be vacated **by noon on the day of departure**.
- **The rental** is rented from Saturday or Wednesday in July and August for a minimum of 7 days. It is available **from 4 pm until 6.30 pm on the day of your arrival** and must be vacated **before 10 am on the day of your departure**. Outside this period, you have the possibility to rent at the weekend.
- The day of your arrival, you will be asked for a **deposit of 300€** to cover the expenses due to possible damage and a **deposit of 70€** for the household for the rental or a **deposit of 20€** for the access card barriers for the bare sites. They will be returned to you on the day of your departure according to the inventory.
- **It is strictly forbidden to smoke in the rental**, any gap will result in **the cashing of the deposit of 300€**.
- Claims must be submitted in the first hours of the stay.
- For rental, the number of people who can use the equipment is 2, 4 or 6 depending on the type of rental. It is a maximum; Any excess (after authorization of the management) will be invoiced in addition. In the event of an inaccurate declaration by the lessee, this contract shall be terminated ipso jure and the sums paid shall be forfeited to the lessor.
- For hygiene reasons, **sheets are not provided**.
- For the slots, you must have a power adapter for **European plug**, so that you can connect to the electrical terminal of your location.

## Rules

- The tenant will respect the rules and will respect it to his children.
- The day: respect of the premises (the site is kept in perfect condition); Respect of the neighborhood (attention to noise).
- Night: absolute silence from 11 pm, except in the entertainment room during the evening shows (23h30). The camping is prohibited from any traffic between 11pm and 8 am..
- **Visitors must present themselves at the reception desk**. Their vehicles must remain outside the campsite. **The visitor does not have access to the swimming pool**.
- Our friends dogs and cats will be welcome if they are kept on a leash inside the campsite. They must in no case remain alone on the site. Dogs of 1st and 2nd category are forbidden. A single animal is accepted in the hirings and by location..
- **Electric barbecues are prohibited**. Campfires are prohibited. Barbecues with charcoal and gas are permitted and remain under the responsibility of the tenants in the event of fire or accident.
- Access to the swimming pool is free for the guests of the campsite. **Swim shorts and underpants are not allowed** (pants and boxers only allowed). Children under 10 not accompanied by an adult are prohibited.
- Children are under the supervision and responsibility of parents. Compliance with posted recommendations is mandatory.

## Responsibility

- During your stay at the campsite you and the participants of this stay are likely to be photographed and filmed, for the advertising needs of the campsite (website, Facebook page, camping leaflet) without limitation of duration. If not, please fill in the following certificate : I, the undersigned ..... does not allow the camping to publish, edit or represent my image and that of all participants in this contract for its advertising needs

- The responsibility of the establishment is not committed in case of theft, loss or damage of any kind during or following the stay and in case of breakdown or decommissioning of technical equipment.
- In the event of non-compliance with the regulation causing discomfort to others, the management reserves the right to break the contract without compensation.
- The campers are responsible for the equipment put at their disposal in the rental. Any damage, breakage or theft will be at his charge.
- Voluntary deterioration or due to misuse of the external facilities provided, will be borne by the campers.
